Until May 1, 2010 fees for an exhibit space are \$35 for a for-profit business and \$20 for a non-profit. After May 1, fees are \$50 and \$25 respectively. Checks are to be made out to Mesa Verde Country Festivals with Verde Fest in the memo line. You will be contacted by email to confirm your exhibit space. We need to receive your application by July 15 to include you in the program information given to each attendee.

Exhibit Rules

Exhibit spaces are all 10' X10' spaces. Exhibitors must provide all display furnishings (table, chairs and shade structure) and display materials. Non-profits must provide their 501(c)3 number. Exhibitors making sales must collect sales tax. City of Cortez sales tax (4.05%) will be collected at the end of the event. Exhibitors are responsible for paying their own State Tax.

Exhibit set-up will begin at 7:30 A.M. on the morning of the event. Please check in at the M-CAN booth before you start unloading. Vehicles are allowed on the grass until 9:30 A.M. Please leave curbside parking for **Verde Fest** visitors. Once unloaded, you can find parking in the parking lot west of the Dolores State Bank and on the street north of City Park.
